



The Church Council has called a Special Congregational Meeting for Sunday, November 19, 2017 immediately following Worship. The purpose of this meeting is to vote on our revised Constitution. Our current constitution and bylaws was last amended in 2001. The churchwide assembly biennially adopts amendments to the Model Constitution, therefore there were numerous amendments to consider to 'bring' ELC's document into compliance with the 2016 required provisions. Given this, the church council decided in November 2016 to adopt the Model Constitution for Congregation of the Evangelical Lutheran Church in America 2016 as a base document and to appoint a Congregational Constitutional Review Committee (CCRC) to review the model document and recommend modifications, where permitted, to fit our local situation and practice.

Pastor Mark Morgenstern, Ron Jore, Sharon Wolske, Maryann Morgenstern and Kristianne Wilson comprised the CCRC. They met on 4 occasions over the spring of 2017 to compare the ELCA Model Constitution with Emmanuel's

current constitution. Their recommendations were discussed and agreed to by the church council at their July and August meetings. Revisions to Emmanuel Lutheran Church's constitution were submitted, reviewed and approved by the Synod Reviewer in early October. The next steps involve a two meeting process, approval at a legally called congregation meeting currently set for November 19 and a subsequent ratification without changes at the next annual meeting, January 2018, date to yet be determined.

The Lord is near. <sup>6</sup>Do not worry about anything, but in everything by prayer and supplication with thanksgiving let your requests be made known to God. <sup>7</sup>And the peace of God, which surpasses all understanding, will guard your hearts and your minds in Christ Jesus."

Philippians 4:4-7

In one sense, I think Paul is saying that our lives as Christians should be characterized by thanksgiving.

On All Saints Day we give thanks to God for all those

people of faith who have gone before us and are faithful witnesses to Jesus. It is truly a time to remember and give thanks for those people who have been instrumental in the development of our faith lives. I can think particularly of my parents, grandparents and a couple of very special pastors. I encourage you to take some time now at the beginning of the months to thank God for similar people in your life. If you are fortunate to have some of those people still alive this might be a good time to thank them personally.

THANKSGIVING

On November 23<sup>rd</sup> our nation will observe a day of Thanksgiving. This is a national holiday not a religious one. Its original intent was to pause and give thanks to God for the blessings God has bestowed on the nation. Now it seems more an excuse to overindulge in eating, watch football and begin our consumeristic indulgence leading up to Christmas. In many places Thanksgiving worship services have been discontinued or are very poorly attended. Perhaps we need to regain our focus of thanking God for the blessings we have received.

We close out the Church Year with Christ the King Sunday. This festival declares that God is the ultimate authority in our lives and not the rulers of this world. The declaration—"Jesus is Lord of all"—can perhaps get us back on the right track. We have reason to give thanks because in Jesus has made us right with God and we can live our lives confidently in God's love and forgiveness. In everything give thanks! ## **Special Congregational Meeting**

As background, The Model Constitution for Congregations of the Evangelical Lutheran Church in America, like the other governing documents of this church, reflects the theology and polity of this church as it organizes itself to preach the gospel of Jesus Christ, share the sacraments, reach out to the neighbor with good news and share the love of God in the world. Each expression of this church — churchwide. synod, and congregation — is held together in a relationship of interdependence that encourages each to respond to its context. These documents also demonstrate our commitment to seeing ourselves with others as part of the one, holy, catholic, and apostolic Church. As such, the Model Constitution for Congregations is deeply rooted in Scripture, the Lutheran Confessions, and the history of this church and its predecessors. The document includes both mandated/required and non-mandated provisions, allowing flexibility to recognize the context of local organizations. Required constitutional provisions are identified with an asterisk \*. Bylaws and continuing resolutions are independent from the constitution, though congregations are encouraged to integrate them into their constitution for clarity. Bylaw provisions follow constitutional provisions to which they apply and continuing resolutions are intended to provide descriptions of operational patterns and practices or of the ongoing responsibilities of committees. Both have unique nomenclature separate from constitutional provisions.

- · C 5.04 defines congregation role of choosing voting members to the Synod Assembly
- · C 5.05 outlines the ability of a congregation to have a Mission Endowment Fund operating as per congregations' bylaws and for the purpose of mission work beyond the operations budget.

Chapter 6- Church Affiliation

- $\cdot$  C 6.03 includes language which allows a congregation to call under special circumstances and with the approval of the Synod bishop, a minister of Word and Sacraments from a church body which the ELCA has established a full communion relationship
- · C 6.04 new terminology regarding Ministers of Word and Service—replaces the prior terms of associates in ministry, diaconal minister and deaconess
- · C 6.05 new language and detailed process to terminate relationship with the ELCA
- · C 6.07 new provision should a congregations consider developing an additional site for worship

· C 7.03-05 should a congregation terminate the relationship with the ELCA these provisions detail the property ownership issues and involvement of the synod.

Chapter 9- Title Change to Rostered Ministers

Language changes throughout the chapter approved in 2016 - replaced clergy and pastor with ministers of Word and Sacrament

C 9.15 allows an interim pastor to be from a full communion partner of the ELCA if the bishop and the congregation approve

· C 9.21-31 new provisions outline the call and termination process for Ministers of Word and Sacrament

Chapter 11 - Officers

Addition of a vice president C11.01

Bylaw language integrated to delineate responsibilities of the officers

All officers' terms are 2 year with a limit of 2 consecutive terms.

Chapter 12 - Congregation Council

Move to electing 6 undesignated Council positions. C 12.0. Delineate the role of deacons and trustees in continuing resolutions CR 12.04A2018 and CR 12.05A2018. These positions remain 3 year terms with the ability to serve 2 consecutive terms.

Change the Director of Youth Education, formerly the SS Superintendent, to a Council appointed position. CR12.04B2018

Delineates the Council may enter into contracts up to \$5,000. for non-budgeted items.

Change the Financial Secretary to a Council appointed position. CR12.05B2018

Chapter 13 - Congregation Committees

Delineate the function of the Executive Committee through a continuing resolution.

Delineate the role of the Audit Committee through a continuing resolution. Committee members are not to be Congregation Council members. The current constitution includes an audit committee which has not been our

current practice. Suggested language includes an external audit every 5 years if indicated

Delineate the functions of a Call Committee through a continuing resolution

Delineate support for youth education and the Director by including a constitution provision for the Youth Ministry Team. Our current constitution outlines a Parish Education Committee which is not current practice.

Mission endowment fund language pending

In general, these changes create greater accountability for the Council, given the appointment of 2 positions which have been historically elected by the congregation- that is the Financial Secretary and the SS Superintendent. The Council will also need to constitute an Audit committee each year.

Chapter 15 – Title change Discipline of Members <u>and</u> <u>Adjudication</u> more detailed and due process language, inclusion of a synod committee if necessary

Chapter 16 - Amendments

· C 16.04 allows for a one step, single congregational meeting to approve constitutional amendments that bring any section into conformity the Model Constitution of the ELCA ( versus the current two-step process, a congregational meeting to review and approve and subsequent ratification at the next annual congregation meeting)

Chapter 17- Bylaws

· C 17.02 bylaws may be adopted or amended at a congregation meeting with a quorum present and 2/3 vote (current constitution has a majority vote)

Chapter 19 – Indemnification new mandated chapter

Chapter 20 – Parish Authorization not a mandated chapter but the CCRC recommends including should in the future our congregation seek to partner with another ELCA congregation.

# CHURCH COUNCIL MEETING 1011/2017

Members present: Pastor Mark, Laurel, Liz, Wade, Karen, Randy, and Abbey Emmons

**DEVOTIONS:** Reading from Romans 1:8-12 and worksheet about strengthening congregations

Abbey Emmons stopped by the meeting to address a few things about keys and locks for the church. There was a realtor box purchased that she would like to have mounted to the wooden power pole by the north corner of the pantry for food deliveries. The only people with keys to the pantry are Louis & Rachell, Matt, Liz, Pastor Mark, Randy, and Rob & Abbey. If one of these people aren't available, the code can be given out for access to the pantry and then the code to the box can be easily changed. Wade will take care of this. Some groups using the church are forgetting to lock the deadbolts upon leaving so it was requested that if you are ever in the area and have a key, please drive by the church and if you can, please check the doors. Need to have the lock for the ramp door changed so it matches the other locks. Some groups using the church are forgetting to lock the deadbolts upon leaving.

Requesting to have a sign board added to the door by the sanctuary doors for notes and updates. Suggested an idea to support the food pantry by putting a note on the board (i.e. "It's Peanut Butter and Jelly month) in hopes to get the groups using the church and anyone else that reads the sign to bring the designated monthly items to the church. Wade has volunteered to construct our new sign board.

**SECRETARY:** Approved as written.

**TREASURER:** We are down to \$7333 on the parking lot loan which is about ½ of the original amount. Funds were short for the Portico insurance payment, so funds were borrowed from the youth account and will be paid back. E-Giving YTD \$11,731. Treasurer's report approved as printed.

**DEACONS:** Liz will be doing a Mission Cornerstone regarding the startup of the backpack program again. We now have 20 kids that are requesting these bags. The shopping cart will be put in the back of the sanctuary for donation. Requested items would be things a kid can eat/prepare for themselves. Working with Family Services to see if they will give us any of their excess groceries for the pantry. Usual contact with the Food Bank is no longer there but she is still working with them on donations.

**TRUSTEES:** Still need heat for the pantry and Matt is working on this. Mark and Shane fixed the outlet in the pantry. Shane is going to split the wiring so the pantry common area and the storage area can have separate lighting. Currently all lights are on one switch. Randy

talked to a guy with Billings Insulation regarding the insulation in the ceiling of the pantry and he said it would cost about \$450 which would keep us within our budget of the \$5000 that was donated.

**PASTOR:** Text studies, confirmation started with 3 kids and sounds like a 4<sup>th</sup> will be joining, St Johns Worship on 10/1. Received word that Brianne will no longer be playing for Sunday services. Daisy has agreed to play on the 1<sup>st</sup> and 3<sup>rd</sup> Sundays and Christmas Eve and Laura will be playing the 2<sup>nd</sup>, 4<sup>th</sup>, and 5<sup>th</sup> Sundays of each month. Thank you both!! There will be an area wide reformation service at American Lutheran Church at 3pm. Billings, Laurel, and Shepherd Lutheran churches are invited and asked to bring cookies/brownies/etc. for the event. If you are attending, you can bring your goodies with you. If you cannot attend but would like to bring treats, please bring them with you to church on Sunday 10/29 and Pastor will make sure they (at least half) make it to the service. Harvest Dinner

is November 5<sup>th</sup>. There will be no Thanksgiving service again this year. Christmas program will be December 17. Will have normal Sunday service on Christmas Eve as well as the evening candlelight service.
